### What does the fund invest in?

The fund will generally allocate its assets to other funds managed by Dimensional Fund Advisors Canada ULC, and its affiliates that invest in Canadian, U.S. and international (including emerging markets) equity securities, real estate securities, and fixed income securities. Generally, the fund will allocate its assets in other funds to achieve a target allocation of 80% (with an allocation under normal market conditions of approximately 70% to 90%) in funds that invest primarily in equity securities and real estate securities, and a target allocation of 20% (with an allocation under normal market conditions of approximately 10% to 30%) in funds that invest primarily in fixed income securities. The underlying funds invest in a broad and diverse group of securities with an increased exposure to small issuers and value securities (for equity), with precisely defined maturity ranges and credit quality (for fixed income) and engaged in the real estate industry with focus on REITs and REIT-like entities (for real estate).

The sub-advisor may also invest the fund's assets directly in equity and fixed income securities.

The charts below give you a snapshot of the fund's investments on April 30, 2016. The fund's investments will change.

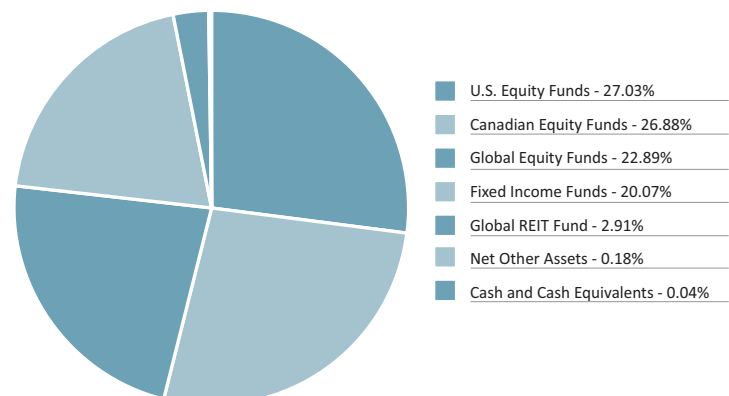

### How risky is it?

The value of the fund can go down as well as up. You could lose money.

One way to gauge risk is to look at how much the fund's returns change over time. This is called "volatility".

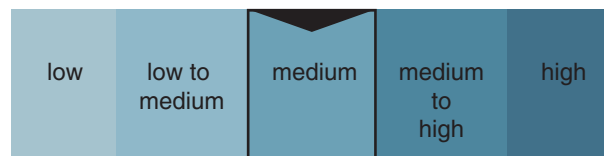
In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

### Risk rating

Dimensional Fund Advisors Canada ULC has rated this fund's risk as **medium**.

This rating is based on how much the fund's returns have changed from year to year. It doesn't tell you how volatile the

fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

### How has the fund performed?

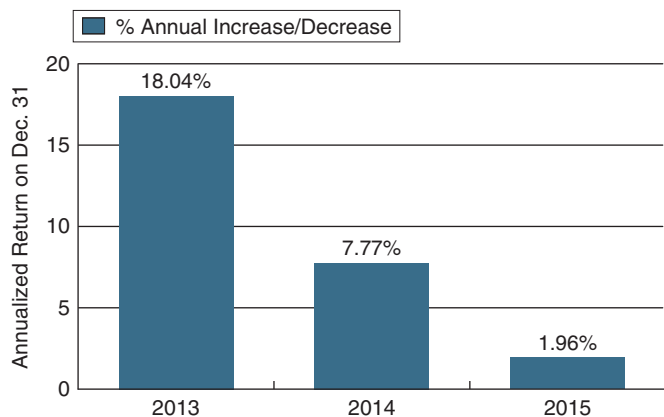
This section tells you how this class of the fund has performed over the past 3 years. Returns are after expenses have been deducted. These expenses reduce the returns of the class.

#### Year by Year returns

This chart shows how this class of the fund performed in each of the past 3 years. The class did not drop in value in the years shown.

The range of returns and change from year to year can help you assess how risky the fund has been in the past. It does not tell you how the fund will perform in the future.

### Best and worst 3-month returns

This table shows the best and worst returns for the units of the fund in a 3-month period over the past 3 years. The best and worst 3-month returns could be higher or lower in the future. Consider how much of a loss you could afford to take in a short period of time.

### Average return

A person who invested \$1,000 in this class of the fund since its inception would have \$1,376.27 as of April 30, 2016. This works out to an annual compound return of 9.17%.

### Who is this fund for?

This fund is appropriate for investors seeking total return of long-term capital appreciation and income from investment primarily in Canadian, U.S. and international (including developed and emerging markets) equities and real estate securities and with some exposure to Canadian, U.S. and international fixed income securities. It would be suitable, therefore, for investors with a medium tolerance for risk and a long-term investment time horizon.

This fund is not appropriate for investors who are unwilling to accept fluctuations in the market value of their investment or for investors who do not want to invest in a fund that invests in other funds managed by Dimensional Fund Advisors Canada ULC and its affiliates.

## A word about tax

In general, you pay tax on your share of the fund's earnings and on taxable capital gains and losses you realize from redeeming your investment. The amount of tax depends on the tax rates that apply to you, and the type of earnings realized by the fund (e.g. interest, dividends, capital gains, etc.). In general, registered retirement savings plans and other registered plans do not pay tax on investments; however, tax may be payable when money is withdrawn from the registered plan (other than from a tax-free savings account).

Keep in mind that if you hold your fund in a non-registered account, fund distributions are included in your taxable income, whether you get them in cash or have them reinvested.

If you hold your investment outside of a registered plan, we will send you a tax slip that shows your share of the fund's earnings. You must calculate your taxable capital gains and losses realized on redemption.

## How much does it cost?

The following tables show the fees and expenses you could pay to buy, own and sell units of this class of the fund. The fees and expenses – including any commissions – can vary among the classes of the fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other funds and investments that may be suitable for you at a lower cost.

### 1. Sales charges

The fund does not impose a sales charge. Your representative or representative's may charge you a sales charge, commission or service fee. These charges are negotiated between you and your representative or representative's.

### 2. Fund expenses

You don't pay these expenses directly. They affect you because they reduce the returns of this class. As of December 31, 2015, the expenses of this class were 0.48% of its value. This equals \$4.80 for every \$1,000 invested.

### More about the trailing commission

Dimensional Fund Advisors Canada ULC does not pay your representative's firm a trailing commission for this class of units you own of the fund.

### 3. Other fees

You may have to pay other fees when you buy, hold, sell or switch units of the fund.

<u>Fee</u>	<u>What you pay</u>
<b>Fee-based accounts</b>	Class F and F(H) units have lower fees than Class A and A(H) units and are usually only available to investors who have fee-based accounts with dealers who have signed an agreement with us. We do not pay trailer fees to dealers who sell Class F and F(H) units, which means we can charge a lower management fee. The highest possible rate or range for the fees charged by your dealer cannot be determined by us. You should contact your dealer for this information.
<b>Short-term trading fee</b>	In order to protect unitholders from the costs associated with investors moving quickly in and out of the fund, we may put in place a short-term trading fee of up to 2% of the value of your units if you switch or redeem units within 60 days of buying units of the fund. This fee will go to the fund.
<b>Switch fee</b>	As described above, you may be charged a short-term trading fee of up to 2% of the value of your units if you switch or redeem units within 60 days of buying units of the fund. This fee goes to the fund.
<b>Redemption fee</b>	As described above, you may be charged a short-term trading fee of up to 2% of the value of your units if you switch or redeem units within 60 days of buying units of the fund. This fee goes to the fund.

**What if I change my mind?**

Under securities law in some provinces and territories, you have the right to:

- withdraw from an agreement to buy mutual fund units within two business days after you receive a simplified prospectus or Fund Facts document, or
- cancel your purchase within 48 hours after you receive confirmation of the purchase.

In some provinces and territories, you also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the simplified prospectus, annual information form, Fund Facts document or financial statements contain a misrepresentation. You must act within the time limit set by the securities law in your province or territory.
